The Company will be using Boardroom Share Registrars Sdn. Bhd.'s ("**Boardroom**") AGM solution which is available on the designated link at <https://meeting.boardroomlimited.my>. Shareholders are reminded to kindly check announcements for the latest announcements or updates, if any, regarding the status of the AGM.

MODE OF MEETING

With reference to the revised 'Guidance and FAQs on the Conduct of General Meetings for Listed Issuers' issued by the Securities Commission Malaysia ("**SC's Guidance**") on 7 April 2022, listed issuers are encouraged to continue leveraging technology in conducting general meetings beyond Movement Control Order.

In addition, in line with the Malaysian Code on Corporate Governance Practice 12.3, by conducting a virtual AGM, this would promote greater shareholder participation as it facilitates electronic voting and remote shareholders' participation. With the virtual meeting facilities, you may exercise your right as a member of the Company to participate (including to pose questions to the Board of Directors and/or Management of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the AGM.

Please note that it is your responsibility to ensure the stability of your internet connectivity throughout the Meeting as the quality of the live webcast and online remote voting is dependent on your internet bandwidth and stability of your internet connection.

ENTITLEMENT TO PARTICIPATE AND VOTE

Only a depositor whose name appears on the Record of Depositors of SNS as at 1 July 2024 shall be entitled to attend the AGM via RPV facilities or appoint a proxy(ies) to participate and vote on his/her behalf by returning the proxy form. A proxy must be 18 years and above and need not be a member of the Company.

BROADCAST VENUE

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires that the Chairman of the meeting to be present at the main venue.

Shareholders/proxies/corporate representatives **ARE NOT ALLOWED to be physically present** nor will they be admitted at the broadcast venue on the day of the AGM. Shareholders/proxies/corporate representatives who turn up at the Broadcast Venue would be requested to leave the venue politely.

LODGEMENT OF PROXY FORM

If you are unable to attend the AGM and wish to appoint the Chairman of the AGM as your proxy to vote on your behalf, please deposit your proxy form at the office of the Company's Share Registrar, **Boardroom Share Registrars Sdn Bhd ("Boardroom") at 11th Floor, Menara Symphony, No. 5, Jalan Prof. Khoo Kay Kim, Seksyen 13, 46200 Petaling Jaya, Selangor Darul Ehsan, Malaysia** not less than forty-eight (48) hours before the time of holding the AGM, i.e. latest by **Wednesday, 10 July 2024 at 10.00 a.m.** Any alteration to the Form of Proxy must be initialled.

Alternatively, the proxy appointment may also be lodged electronically at <https://investor.boardroomlimited.com>, which is free and available to all individual shareholders, not less than forty-eight (48) hours before the time of holding the AGM, i.e. latest by **Wednesday, 10 July 2024 at 10.00 a.m.** For further information, kindly refer to the "Electronic Lodgement of Form of Proxy" below.

(Note: If you have already signed up with BSIP, you are not required to register again. You may proceed to Step 2 on eProxy Lodgement.)

- a. Go to BSIP website @ <https://investor.boardroomlimited.com>.
- b. Click **<<Register>>** to sign up as a user.
- c. Please select the correct account type i.e. sign up as **"Shareholder"** or **"Corporate Holder"**
- d. Complete registration with all required information. Upload and attached your MyKAD front and back image (for Malaysian) or Passport (for foreigner). For Corporate Holder, please upload the authorisation letter (template available) as well. Click **<<Register>>**.
- e. You will receive an e-mail from BSIP Online for e-mail address verification. Click on **<<Verify E-mail Address>>** from the e-mail received to proceed with the registration.
- f. Once your email address is verified, you will be re-directed to BSIP Online for verification of mobile number. Click on **<<Request OTP Code>>** and an OTP code will be sent to the registered mobile number. You will need to enter the OTP Code and click **<<Enter>>** to complete the process.
- g. Once your mobile number is verified, registration of your new BSIP account will be pending for final verification.
- h. An e-mail will be sent to you to inform the approval of your BSIP account within one (1) business day. Subsequently, you can login at <https://investor.boardroomlimited.com> with the e-mail address and password filled up by you during registration to proceed.

Step 2 eProxy Lodgement

For Individual/ Corporate Shareholder

- a. Go to BSIP website @ <https://investor.boardroomlimited.com> and login with your registered email address and password from Step 1 above.

- b. Select and click on << **Meeting Event**>>.
- c. Go to **SNS NETWORK TECHNOLOGY BERHAD 2024 ANNUAL GENERAL MEETING** and click <<**Enter**>>.
- d. Click on <<**Submit eProxy Form**>>.
- e. Select the company you would like to be represented (if more than one), for Corporate Shareholder.
- f. Enter your CDS Account Number and insert the number of securities.
- g. Appoint the Chairman of the meeting or your proxy(ies).
- h. Read the terms & conditions and confirm the declaration by clicking “**Next**”.
- i. Enter the required particulars of your proxy(ies)
- j. Indicate your voting instructions – **FOR or AGAINST**, otherwise your proxy(ies) will decide your votes during the meeting.
- k. Review and confirm your proxy(ies) appointment.
- l. Click <<**Apply**>>; and
- m. Download or print the e-proxy Form acknowledgment.

For Authorised Nominee and Exempt Authorised Nominee

- a. Go to BSIP website at <https://investor.boardroomlimited.com> and login with your registered email address and password from Step 1 above.

- b. Select “**SNS NETWORK TECHNOLOGY 2024 ANNUAL GENERAL MEETING**” from the list of Meeting Event and click “**ENTER**”.
- c. Click on “**Submit eProxy Form**”.

- e. Proceed to download the file format for “**Submission of Proxy Form**” from BSIP.
- f. Prepare the file for the appointment of proxies by inserting the required data.

- h. Review and confirm your appointment and click "Submit".
- i. Download or print the eProxy form as acknowledgement.

Notes:

- ***If you are the authorised representatives for more than one (1) authorised nominee / exempt authorised nominee/corporate shareholder, kindly click the home button and select "Edit Profile" in order to add company name.***
- Closing for proxy form submission is at 10.00 a.m. of Wednesday, 10 July 2024 (48 hours before the AGM)

If you wish to participate in the AGM yourself, please do not submit any proxy form for the AGM. You will not be allowed to participate in the AGM together with a proxy appointed by you.

REVOCAION OF PROXY

If you have submitted your Proxy Form prior to the AGM and subsequently decide to appoint another person or wish to participate in the AGM yourself, please write in to bsr.helpdesk@boardroomlimited.com to revoke the earlier appointed proxy(ies) at least forty-eight (48) hours before the AGM. On revocation, your proxy(ies) will not be allowed to participate in the AGM. In such event, you should advise your proxy(ies) accordingly.

VOTING PROCEDURE

The voting will be conducted by poll in accordance with Rule 8.31A of Bursa Malaysia Securities Berhad's Ace Market Listing Requirements. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting (e-Voting) and Boardroom Corporate Services Sdn. Bhd. as Independent Scrutineer to verify the poll results.

Members and proxies are required to use one (1) of the following methods to vote remotely:

- (i) Scan the QR Code provided in the user login guide.
- (ii) Navigate to the website at <https://meeting.boardroomlimited.my>.

During the AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence as soon as the Chairman calls for the poll to be opened and until such time when the Chairman announces the closure of the poll. Kindly refer to voting procedures under RPEV for guidance on how to vote remotely at <https://investor.boardroomlimited.com>.

For the purpose of this AGM, e-Voting can be carried out by using either personal smart mobile phones, tablets, personal computers or laptops.

The polling will only commence after announcement of poll being opened by the Chairman and until such time when the Chairman announces the closure of poll.

The Independent Scrutineer will verify the poll result reports upon closing of the poll session by the Chairman. Thereafter, the Chairman will announce and declare whether the resolutions put to vote were successfully carried or otherwise.

VIRTUAL MEETING FACILITIES
